Subject: Sweep operation in Kibuye

Mr *Secetur* Commander,

I have the honor to inform you that during the Council of Ministers this Friday 17 June 1994, the government decided to request the Operational *Secetur* Commander in GISENYI, with support of the population, to perform a cordon and search operation by the Gendarmerie in Kibuye in the Biseseero area of *Gishyika commune* which has become a sanctuary for the RPF.

The government asks that this operation be finished no later than 20 June 1994.

In the absence of the Minister of Defense, who is on mission abroad, the Minister of Interior and Communal Development has been mandated to communicate this decision and to ensure it is followed up.

The *Préfet* of Kibuye préfecture as well as the group commander in Kibuye, to whom I have issued a copy of this letter, are kindly requested to make arrangements to facilitate the realization of this operation in the time allowed.
