In the event that any confidential material was made public, I would kindly request that such material be removed and that any other documents you may have published be reviewed, to ensure that no other confidential information has been made publicly accessible.

Dear Professor Erlinder,

Thank you for your message. I appreciate your continued willingness to work with the Registry.

With respect to the documents pertaining to the *Bagosora et al.* case record, I confirm that the 137 exhibits which I brought to your attention on 5 August are confidential and are not to be republished. I note that they are no longer publicly accessible since you voluntarily took down the website. Should you have specific questions regarding the individual documents, please let me know.

With respect to the approximately 3,000 documents from various sources, which did not appear to originate from the ICTR/MICT judicial records and which were contained in the "United Nations" section of the website, the Registry conducted a preliminary review of 57% of these documents, prior to the site being taken down. Based on this assessment, the Registry is concerned about:

- 1) potential implications on witness protection, as 25% of the documents contain names of individuals who were not immediately recognizable as public figures and may be protected witnesses;
- 2) the potentially confidential nature of some of these documents, most of which originate from the United Nations. I note that 10% of these are marked as confidential or restricted and 2% are labelled as drafts.

As the website has been taken down, we have not been in a position to continue with our review of the documents and necessary further analysis. Thus, at this stage, it is difficult for us to pinpoint which specific documents may be problematic among the 57% which we have already reviewed, or give you information regarding the remaining documents which were posted in the "United Nations" section of the website. A full Registry review of the 3,000 documents would be necessary to assist us in identifying any additional individual who may have been affected by the disclosure of sensitive information and offering you guidance for the re-publication of these materials.

Considering the concerns which we have preliminarily identified, we advise against re-publishing the website at this stage, as this would result in sensitive information being again publicly available. However, in order for us to complete our full review of the documents, we would propose that you either: 1) bring the website back online with access to limited MICT staff through username and password; or 2) create an image copy of the website from the server and put it on a hard drive disk which would be sent to MICT. I could assign one of my colleagues in the Registry to guide you through this process, should you need any assistance.

Regarding the remaining "non-UN categories" of documents which appeared on the website, before agreeing in principle to the republication of these documents, the Registry would have to conduct a preliminary review, to confirm that there are no potential witness protection issues or other concerns with regard to confidentiality.

Again, I thank you for your continued cooperation. As scheduled, I will call you next Tuesday and will be happy to answer any questions or concerns as they arise.
