STATEMENT CALLS FOR AN END TO THE MASSACRES, AN IMMEDIATE CEASE-FIRE WITH GEN DALLAIRE TO CONVENE DISCUSSIONS, AND FORESEES A POSSIBLE INTERNATIONAL PRESENCE TO MONITOR THE CEASE-FIRE, AND PROVIDE HUMANITARIAN ASSISTANCE, PROTECTION FOR CIVILIANS, AND HUMAN RIGHTS MONITORING, AND CALLS FOR A RETURN TO THE ARUSHA NEGOTIATIONS. MALECELA OUTLINED THE POSITIONS OF THE PARTIES.

HE OUTLINED SOME AREAS OF POTENTIAL AGREEMENT INCLUDING ON CEASE-FIRE NEGOTIATION TERMS, AN INTERNATIONAL PRESENCE. MALECELA STRESSED THAT A CEASE-FIRE IS PARAMOUNT, ANALYZED THE ROLE OF NEIGHBORING GOVERNMENTS, BOTH IN ATTAINING A CEASE-FIRE AND AT A POTENTIAL REGIONAL SUMMIT. END SUMMARY.

4. A/S SHATTUCK BEGAN BY EXPRESSING PRESIDENT CLINTON'S APPRECIATION FOR TANZANIAN FACILITATION OF THE ARUSHA TALKS AND FOR WELCOMING REFUGEES TO TANZANIAN TERRITORY. HE SAID THE U.S. AND TANZANIA SHOULD WORK TOGETHER AND WITH THE INTERNATIONAL COMMUNITY TO END THE KILLINGS IN RWANDA, ACHIEVE A CEASE-FIRE, PROVIDE HUMANITARIAN ASSISTANCE AND PROTECTION TO CIVILIANS, AND TO BEGIN AN INQUIRY INTO HUMAN RIGHTS VIOLATIONS.

5. A/S SHATTUCK WENT ON TO DESCRIBE U.S. HUMANITARIAN ASSISTANCE THUS FAR AND TO EXPRESS SUPPORT FOR PROPOSED UNSC RESOLUTIONS TO IMPOSE AN ARMS EMBARGO AND TO RECONFIGURE THE INTERNATIONAL PRESENCE SO IT MIGHT PROVIDE HUMANITARIAN ASSISTANCE AND CIVILIAN PROTECTION.

6. THE PM EXPRESSED HIS GOVERNMENT'S "HIGH APPRECIATION" FOR THE U.S. POSITION. HE PARTICULARLY CITED PRESIDENT CLINTON'S "STRONG AND CLEAR" PUBLIC STATEMENTS ON THE CRISIS IN RWANDA.


