2. LATE NOVEMBER 7, GRB PRESIDENTIAL DIPLOMATIC
COUNSELOR GEDEON MAGETE INFORMED CHARGE THAT
REPRESENTATIVES OF THE UGANDAN CONTINGENT OF THE
RWANDAN CEASE-FIRE OBSERVATION FORCE HAD ARRIVED IN
GOMA THE PREVIOUS DAY FOR TALKS ON ORGANIZATIONAL
ARRANGEMENTS FOR THE FORCE. THE TALKS, SCHEDULED FOR
LAST WEEK, WERE ABANDONED BY THE ZAIRIAN, RWANDAN, AND
BURUNDIAN DELEGATIONS WHEN THE UGANDAN AND RPF
CONTINGENTS FAILED TO APPEAR (REFTEL).

3. ACCORDING TO MAGETE, PRESIDENT BUYOYA IS PREPARED
TO SEND THE BURUNDI DELEGATION BACK TO COMA PENDING
NOTIFICATION THAT THE OAU IS READY TO PARTICIPATE IN
THE PROCESS. WHEN ASKED ABOUT THE STATUS OF RPF
PARTICIPATION, MAGETE SAID THAT THE GRB WILL NOT INSIST
ON AN RPF PRESENCE FOR THE TALKS TO GO AHEAD. DUNN
