2. ROBERT BENTLEY REPORTS FROM ARUSHA THAT TANZANIA REP
AMB AMI MPUNGWE AND GOR FOR MIN NGULINZIRA BRIEFED THE
OBSERVERS ON DECEMBER 1 AND DECEMBER 2 ABOUT THE
MWINYI-HABYARIMANA MEETING IN DAR ES SALAAM ON NOVEMBER
30 AND HABYARIMANA'S DECEMBER 1 STATEMENT. NGULINZIRA
FEELS THAT HE IS READY TO GO, AND EXPECTS FINAL
INSTRUCTIONS FOR THE GOR TEAM MOMENTARILY. WE DEFER TO
KIGALI AS TO WHETHER OPTIMISM IS WARRANTED BUT FROM
ARUSHA IT LOOKS LIKE THERE ARE NOW FAVORABLE NEGOTIATING
PROSPECTS FOR RESOLVING REMAINING POLITICAL ISSUES.

3. BENTLEY'S DETAILED REPORT ON TANZANIA AND RWANDAN
BRIEFINGS WILL BE SENT FROM DAR EARLY DECEMBER 3.
ASSUMING DEPARTMENT AND EMBASSY KIGALI CONCUR THAT THERE
IS POSSIBILITY OF PROGRESS AND THAT POLITICAL
NEGOTIATIONS WILL NOW RESUME IN EARNEST, I STRONGLY URGE
THAT AMBASSADOR ED BRYNN TRAVEL TO ARUSHA AT ONCE.
BENTLEY HAS DONE AN EXCELLENT JOB IN ARUSHA HOLDING THE
FORT AND KEEPING IN TOUCH WITH ALL CONCERNED, BUT IT IS
NOW IMPORTANT FOR US TO BE REPRESENTED BY A MORE SENIOR
OFFICER FLUENT IN FRENCH. IN ADDITION, SINCE I WILL
