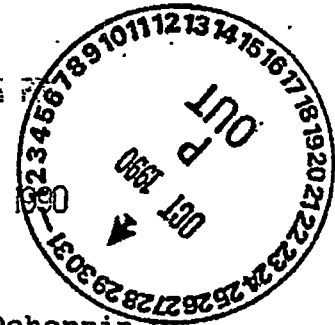

PURPOSE:

- Ambassador Dehennin wishes to discuss regional issues, in particular the Persian Gulf, Rwanda, where Belgium is actively involved militarily, as well as Cambodia, which Belgium follows closely.
- Obtain Belgian readout on the situation in Rwanda, urge Belgium to remain engaged in Desert Shield and to continue its assistance to the front-line states, and discuss the state of play in the Cambodian negotiations.

BACKGROUND:

Ambassador Dehennin has made a point of keeping in close contact with senior levels of the Department about developments in these regions. Belgium has sent two minesweepers and a frigate to support Desert Shield and pulled its six C-130 aircraft from Desert Shield only to deploy troops in Rwanda. The US is depending on these Belgians and the French for the secure evacuation of US citizens wishing to leave Rwanda.
