1. WE ARE PREPARING TO PROVIDE AAFES SUPPORT IN THE RWANDA AO IAW USCINCEUR TASKINGS. INITIAL TASKING IS TO PROVIDE AN IMPREST FUND IN GOMA TO SUPPORT APR 300 PEOPLE (MAY INCREASE TO 567) AND A TFE IN ENTEBBE FOR APR 1000 PEOPLE (MAY INCREASE TO 1800). AAFES-EUROPE-REGION - PL IS THE FOCAL POINT FOR ALL REQUESTS TO AAFES EUROPE AND ALL REQUEST SHOULD CONSIDER:

A. LOGISTICS SUPPORT TO INCLUDE:

(1) TRANSPORTATION FOR MERCHANDISE AND PERSONNEL TO FROM AND

WITHIN THE AO. THIS INCLUDES MOVING AAFES MERCHANDISE CONTAINERS TO THE OPERATIONAL AREAS, AS WELL AS RE-SUPPLY.

(2) BUILDING, TRAILER, TENT, OR OTHER STRUCTURE CAPABLE OF STORING, SELLING AND SECURING AAFES MERCHANDISE.

(3) REASONABLE SECURITY FOR AAFES ASSETS.

(4) REFRIGERATION OR ICE ENHANCEMENTS FOR BEVERAGES.

(5) COMMUNICATION SUPPORT FOR REQUISITIONING FOLLOW-ON SUPPLIES AND MERCHANDISE.

(6) FINANCE SUPPORT TO INCLUDE:

(A) SECURING CASH OVERNIGHT

(B) REPLINISHMENT OF CHANGE FUNDS

(C) CONVERSION OF CASH TO TREASURY CHECKS

(7) TRAINING: OFFICER/SENIOR NCO'S DESIGNATED TO RUN A TACTICAL FIELD EXCHANGE OR IMPREST FUND MUST REPORT TO THE SUPPORTING EXCHANGE FOR INVENTORY AND SIGN-OVER OF AAFES ASSETS, NORMALLY 3 DAYS PRIOR TO DEPLOYMENT.

(8) LOCATIONS (BASES/POSTS/KASERNS) WHERE TROOPS ARE DEPLOYING FROM; TO ALLOW MILITARY CLOTHING SALES STORES (MCSS) TO PROVIDE ITEMS FROM HOME STATION STORES VERSUS CLOTHING STORES AT ENROUTE STOPS.

2. FOR MOST SITUATIONS AAFES-EUROPE CAN INITIALLY SEND A UNIT OPERATED IMPREST FUND UNTIL SUCH TIME AS THE AREA IS SECURE ENOUGH AND CAN SUPPORT A TFE (EUCOM/JTF CALL). ONCE HE REQUEST ARRIVES AT AAFES-EUROPE WE WILL COORDINATE WITH DECA TO SEND PERSONNEL TO SET-UP OR TAKE OVER EXISTING OPERATIONS.

3. AAFES-EUROPE - PL PERSONNEL NEED TO BE KEPT APRISED OF INFORMATION SUCH AS LOCATIONS AND NUMBERS OF PERSONNEL DEPLOYING. THIS ALLOWS ADEQUATE AAFES PLANNING FOR EACH SITE.
