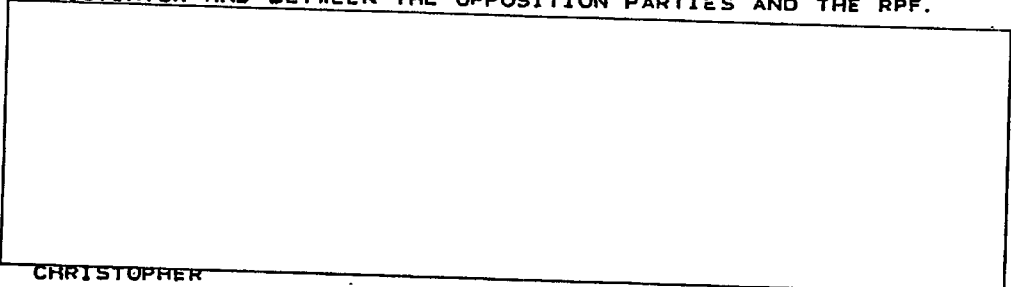

SUBJECT: ARUSHA: ON AND OFF

1. C - ENTIRE TEXT.
2. THE FOLLOWING SUMMARIZES INFORMATION RECEIVED FROM ARUSHA, DAR ES SALAAM, AND KIGALI ON FEBRUARY 3.
3. ACCORDING TO THE LATEST INFORMATION FROM TANZANIA, THE RWANDAN TALIS REMAIN ON THE BRINK OF COLLAPSE. WHILE THE GOR APPEARS CLOSE TO A BREAKTHROUGH ON A MANDATE FOR ITS DELEGATION TO ARUSHA, THE RPF REFUSES TO NEGOTIATE UNTIL THE GOR DEALS WITH ITS DEMANDS FOR SECURITY GUARANTEES. BY FOCUSING ON DIFFERENT PRIORITIES, THE TWO SIDES MAY WIND UP TALKING PAST ONE ANOTHER IN ARUSHA. POOR PHONE CONNECTIONS BETWEEN KIGALI AND ARUSHA APPEAR TO HAVE ACCENTUATED THE LACK OF UNDERSTANDING BY HINDERING ESSENTIAL COMMUNICATIONS BETWEEN THE GOR AND ITS NEGOTIATOR AND BETWEEN THE OPPOSITION PARTIES AND THE RPF.
