1. REFERENCE WAS A UN REQUEST FOR CF AIRLIFT SUPPORT TO UNAMIR FOR A 2 WEEK PERIOD AFTER 24 APR 94, UTILIZING CDN C-130s TEMPORARILY DEPLOYED TO NAIROBI FOR NATIONAL SUPPORT/CONSULAR ASSISTANCE. FOLLOWING DISCUSSIONS WITH DIPOL ON THIS UN REQUEST WE CONVEYED TO UN DPKO CDN INTENTION TO REDUCE AIRCRAFT SUPPORT TO ONE C-130 AS OF 30 APR.

2. WE ALSO ADVISED UNHQ OF OUR WISH THAT THE UN PLAN TO FIND OTHER MEANS FOR UNAMIR AIRLIFT SUPPORT AFTER 8 MAY. WE POINTED OUT TO UN THAT THE REQUIREMENT FOR ONGOING AIRLIFT SUPPORT NEEDED TO BE ADDRESSED AS IT WAS BECOMING APPARENT THAT A MORE PERMANENT ARRANGEMENT SUCH AS UN CHARTER/CONTRACTED LIFT WAS GOING TO BE REQUIRED.
