ACTION SUMMARY

1. Purpose. (U) To alert the government of Kenya to concerns regarding the docking and unloading of ships at Mombasa port in support of Rwanda relief effort. (TAB).

2. Discussion.

a. (C) DOD intends to dispatch heavy equipment and vehicles from Diego Garcia to the area in and around Rwanda. Plans call for the equipment to be moved by ship into Mombasa as the most suitable port of entry available. The government of Kenya granted blanket clearances for the US ships. CENTCOM has sent a two man assessment team to assist in logistics coordination in Mombasa. Attached is a draft cable from DOS to the Kenyan government citing concerns with docking and unloading the ship in Mombasa.

b. (C) The proposed draft alerts the government of Kenya that the ships may tie up port facilities in order to unload military equipment, including explosive ordnance, in order to gain access to the humanitarian supplies. Draft also points out that due to the size of the humanitarian cargo overland movement will be necessary to transport most cargo to destination.

3. (U) Recommendation. DJS approve proposed cable (TAB) with JS changes. AO will relay clearance to DOS.
