Viz: On page 141, strike lines 14 and 15, and insert in lieu thereof:

1 Titles I through VIII of this Act may be cited as the
2 "Department of Defense Appropriations Act, 1995".

3 TITLE IX--FISCAL YEAR 1994 SUPPLEMENTAL APPROPRIATION

4 The following sum is appropriated, out of any money in the
5 Treasury not otherwise appropriated, for the fiscal year ending
6 September 30, 1994, namely:

7 DEPARTMENT OF DEFENSE

8 MANAGEMENT FUNDS

9 Emergency Response Fund

10 For the "Emergency Response Fund", \$170,000,000: Provided,
11 That these funds may be used to reimburse appropriations of the
12 Department of Defense for costs incurred for emergency relief for
13 Rwanda: Provided further, That the Secretary of State shall
14 provide a report to the Congress no later than September 1, 1994,
15 as to the burden-sharing arrangements in the Rwanda relief
16 operation that have been negotiated and implemented with other
17 nations, and international public and private organizations, as
18 to both cost and personnel participation, including armed forces
19 participation: Provided further, That the Secretary of Defense
20 shall provide assessments to the Congress no later than September
21 1, 1994, of (1) any threats to the security of U.S. personnel,
22 including armed forces personnel, in the Rwanda relief operation,
23 and (2) the extent to which the UNAMIR peacekeeping operation has
24 established a security system within the country of Rwanda:

1 Provided further, That any change in the mission from one of
2 strict refugee relief to security, peace-enforcing, nation-
3 building or any other substantive role, shall not be implemented
4 without the further approval of the Congress; Provided further,
5 That U.S. armed forces shall not participate in relief operations
6 inside Rwanda until and unless the President has certified to the
7 Congress that the security situation in the countryside has
8 stabilized to the extent that U.S. forces will not play a
9 peacekeeping or peace-enforcing role between the warring factions
10 inside Rwanda; Provided further, That no funds are available for
11 U.S. participation in operations in or around Rwanda after
12 October 7, 1994; Provided further, That the President shall
13 provide a plan to the Congress by September 15, 1994, as to how
14 he will terminate U.S. involvement in the Rwanda operation by
15 October 7, 1994, unless an extension of time is approved by the
16 Congress, and what arrangements have been made for other nations
17 and international public and private organizations to replace
18 U.S. resources and personnel.
