1. CONFIDENTIAL -- ENTIRE TEXT.
2. EMBASSY KIGALI HAS HAD NO/NO EXPERIENCE WITH AREA F PROJECT IMPLEMENTATION. HOWEVER, WE HAVE HAD SOME CONTACT WITH THE PROCESS THAT MAY BE OF INTEREST TO THE ROUND TABLE ASSESSMENT.

3. KIGALI'S JOINT STATE-AID REQUEST FOR ASSISTANCE UNDER AREA F (92 KIGALI 3546 -- AUGUST), WHEN ELECTIONS WERE EXPECTED BY MARCH 1993 TO END A

YEAR-LONG TRANSITION PERIOD, WENT UNANSWERED. WE DID NOT PRESS THE ISSUE, HOWEVER, BECAUSE IT WAS CLEAR BY LATE 1992 THAT THIS TIMETABLE WOULD SLIP AND A NEW ONE WOULD BE DEPENDENT ON THE OUTCOME OF PROTRACTED PEACE NEGOTIATIONS.

4. WE HAVE CONDUCTED AN ON-AGAIN, OFF-AGAIN DIALOGUE WITH NDI, ONE OF THE AREA F NGO PARTNERS, SINCE THE FIRST NDI TEAM VISIT IN JUNE 1992. A PARTY-BUILDING PROJECT CONCEIVED WITH NDI DURING A FIRST VISIT -- PRE-AREA F -- WAS APPROVED FOR FUNDING (DOLS 125,000) IN OCTOBER 1992 AS AN AREA F PROJECT. THE TIMEFRAME FOR IMPLEMENTATION, TARGETED FOR NOVEMBER 1992 TO EARLY 1993, KEPT GETTING PUSHED BACK, HOWEVER, AS THE PEACE NEGOTIATIONS DRAGGED ON. AS FAR AS WE KNOW, THIS PROJECT IS STILL ON THE BOOKS. IT IS OUR INTENTION

TO ESTABLISH A NEW TARGET DATE AS SOON AS THE TRANSITION INSTITUTIONS CALLED FOR IN THE AUGUST PEACE ACCORD ARE INSTALLED.

5. DURING NDI'S SECOND VISIT TO KIGALI, IN DECEMBER 1992, WE DISCUSSED WITH THE TEAM NOT ONLY THE PROPOSED PARTY-BUILDING SEMINAR AND ITS TIMING, BUT ALSO THE LARGER PLAN FOR ELECTIONS PREPARATIONS ASSISTANCE UNDER AREAFA. NDI EXPRESSED A WILLINGNESS TO CONSIDER BASING A COORDINATOR IN KIGALI, AS REQUESTED IN THE CABLE MENTIONED IN PARA 2, BUT AGAIN, THE DEMOCRATIZATION PROCESS FAILED TO EVOLVE AT THE PACE ANTICIPATED. THIS, TOO, WE WILL WANT TO EXPLORE ONCE A GOVERNMENT IS IN PLACE.

6. GIVEN OUR LACK OF EXPERIENCE WITH AREAFA AND ITS NGO PARTNERS, WE CANNOT COMMENT ON MOST OF THE ISSUES OUTLINED REFTTEL. HOWEVER, THERE IS ONE THAT WE WOULD LIKE TO COMMENT ON: HOW EARLY TO GET INVOLVED AND THE CRITERIA UPON WHICH THESE DECISIONS SHOULD BE BASED.

QUILTING ACTIVITIES SHOULD BEGIN AS SOON AS POSSIBLE ONCE MULTIPLE PARTIES EXIST. THE TRAINING SHOULD NOT BE LIMITED TO HOW-TO INFORMATION (WHICH ALL THE PARTIES IN RWANDA ERRONEOUSLY BELIEVED THEY ALREADY KNEW FROM THEIR ONE PARTY EXPERIENCE). IT SHOULD ALSO BE ABLE TO ADDRESS INTERPERSONAL RELATIONS, RESPECT FOR THE IDEAS OF OTHERS, ACCEPTING LOSSES, AND DEALING WITH THE INABILITY TO CONTROL OUTCOMES IN A DEMOCRATIC PROCESS. NDI RESPONDED SKEPTICALLY TO THIS TYPE OF APPROACH AND ESSENTIALLY DECLINED TO CONSIDER IT IN THEIR PROJECT. THESE NOTIONS ARE ESSENTIAL TO THE PROCESS; AND IF RWANDAN POLITICAL LEADERS HAD BEEN MORE ENDUED, WE MIGHT HAVE INSTALLED TRANSITION INSTITUTIONS BY NOW.

8. THE LATEST CABLE DESCRIBING THE CURRENT INTERESTS OF AREAFA PARTNERS SUGGESTS THAT THE FOCUS IS SHIFTING TO POST-ELECTION CONSOLIDATION. THIS IS CLEARLY IMPORTANT, BUT ELECTIONS SHOULD NOT BE THE SOLE CRITERIA FOR ASSISTANCE. EQUALLY IMPORTANT IS THE ABILITY OF THE GOVERNMENTAL INSTITUTIONS TO FUNCTION ACCORDING TO DEMOCRATIC PRINCIPLES AND NORMS. UNLESS THE DEMOCRATIZATION PROCESS IS ENTRENCHED IN THE INSTITUTIONS, ELECTIONS MAY HAVE EPHEMERAL RESULTS.
