THE OPERATION HAVE UN BLESSING AND BROAD PARTICIPATION. THE MISSION HAD TO BE CLEARLY EXPLAINED TO THE RPF AND RWANDA'S NEIGHBORS AND THEIR APPROVAL SOUGHT.
