DURING FAREWELL CALL BY CHARGE EVENING DECEMBER 7, PRESIDENT MWINYI SAID THAT HE HAD SENT FOREIGN MINISTER DIRIA TO KIGALI THE SAME EVENING TO SEE PRESIDENT HABYARIMANA TO URGE THAT RWANDA PEACE TALKS IN ARUSHA BE PRESSED FORWARD. MWINYI SAID HE WAS FRUSTRATED THAT FOLLOWING HABYARIMANA'S NOVEMBER 30 VISIT TO DAR ES SALAAM NO INSTRUCTIONS HAD BEEN SENT TO RWANDAN GOVERNMENT DELEGATION HEADED BY FOREIGN MINISTER NGULINZIRA IN ARUSHA. INSTEAD THERE WAS MUCH JOCKEYING AMONG PARTIES ON KEY ISSUE OF POWER SHARING WITH NO DECISIONS BEING TAKEN. MWINYI AGREED THAT THERE WERE RISKS OF CEASEFIRE BREAKING DOWN AND THAT PEACE PROCESS NEEDED TO MOVE FORWARD.

3. CHARGE SAID USG APPRECIATED ROLE OF GOVERNMENT OF TANZANIA AS FACILITATOR OF ARUSHA TALKS. WE TOOK OUR ROLE AS ONE OF THE OBSERVERS SERIOUSLY AND HOPED THAT MOMENTUM COULD AGAIN BE INJECTED INTO ARUSHA PROCESS.
