THE AMBASSADOR WILL BE ABSENT THE NEXT TEN DAYS AT THE COM MEETING, LEAVING THE DCM AS CHARGE.
2. EMBASSY DAR IS ALWAYS READY TO HELP, BUT IN VIEW OF THE CIRCUMSTANCES IT WOULD SEEM THE DEPARTMENT'S BEST CHOICE WOULD BE TO SEND COL. MARLEY TO ARUSHA. DE VOS
