ASSISTANT TO THE ASSISTANT SECRETARY JUDITH KAUFMANN MET WITH PRESIDENT MUSEVENI ON MAY 7 TO SIGN A JOINT STATEMENT ON THE SITUATION IN RWANDA. IN ADDITION, A/S SHATTUCK ASKED PRESIDENT MUSEVENI TO SPONSOR A REQUEST FOR A SPECIAL SESSION OF THE UNHRC ON RWANDA, TO WHICH THE PRESIDENT AGREED IN PRINCIPLE. END SUMMARY.

3. ASSISTANT SECRETARY JOHN SHATTUCK, AMBASSADOR DAVID RAWSON, AMBASSADOR JOHNNIE CARSON AND SPECIAL ASSISTANT TO THE ASSISTANT SECRETARY JUDITH KAUFMANN MET WITH PRESIDENT MUSEVENI ON MAY 7. DEPUTY CHIEF OF MISSION SHIPPY, AND ECONOFF BERG (NOTETAKER) ALSO ATTENDED ON THE AMERICAN SIDE. DEPUTY MINISTER OF FOREIGN AFFAIRS AGARD DIDI AND OTHER MFA AND STATE HOUSE FUNCTIONARIES WERE ALSO PRESENT. THE MAIN PURPOSE OF THE MEETING WAS TO SIGN A JOINT STATEMENT OUTLINING THE GOALS OF UGANDA AND THE U.S. IN RWANDA. THE TEXT OF THE STATEMENT WAS REPORTED IN REF B.

4. THE ASSISTANT SECRETARY BRIEFED PRESIDENT MUSEVENI ON HIS MEETING WITH THE RPF (REPORTED SEPTTEL). A/S SHATTUCK NOTED THAT HE WOULD BE TRYING TO REACH GENERAL DALLAIRE BY TELEPHONE TO PUSH FORWARD THE CONCEPT OF A CEASE-FIRE AT THE FIELD COMMANDER LEVEL. A/S SHATTUCK ALSO INFORMED MUSEVENI THAT HE WOULD BE ATTEMPTING TO REACH A RWANDA GOVERNMENT REPRESENTATIVE, AMBASSADOR TO UGANDA KANYANRUSHOKE (WHO WAS IN NAIROBI).

5. THE PRESIDENT REITERATED HIS BELIEF THAT PUTTING JUSTICE AT THE CENTER OF DISCUSSIONS THROUGH AN INTERNATIONAL INQUIRY INTO THE CAUSES OF RWANDAN VIOLENCE WOULD HELP ACCELERATE RPF ACCEPTANCE OF OTHER OBJECTIVES, SPECIFICALLY A DURABLE CEASE-FIRE AND AN INTERNATIONAL HUMANITARIAN PRESENCE.

6. THE ASSISTANT SECRETARY POINTED TO THE UTILITY OF A SPECIAL SESSION OF THE UN HUMAN RIGHTS COMMISSION TO FOCUS ATTENTION ON RWANDAN HUMAN RIGHTS VIOLATIONS. PRESIDENT MUSEVENI AGREED IN PRINCIPLE TO FIND AN AFRICAN MEMBER OF THE COMMISSION TO SPONSOR A FORMAL REQUEST FOR A SPECIAL UNHRC SESSION.
