SUBJECT: APPARENT DISINFORMATION CAMPAIGN AGAINST GOR
1. EMBASSY HAS RECEIVED A PHOTOCOPY OF AN ALLEGED
LETTER SENT TO PRESIDENT JUVENAL HABYARIMANA ON AUGUST
2 BY A FRENCH ANTI-DRUG OFFICIAL. FROM THE CONTENT OF
THE LETTER, WE ASSUME THAT IT IS PART OF A
DISINFORMATION CAMPAIGN BY THE RPF OR OTHER DISAFFECTED
RWANDANS DESIGNED TO DISCREDIT THE GOR, PRESIDENT
HABYARIMANA IN PARTICULAR.
2. THE DISINFORMATION EFFORT IS SO CRUDE THAT IT
VERGES ON THE COMICAL. IT IS DOUBTFUL THAT ANY
EDUCATED PERSON WHO READS IT WILL CONSIDER IT
BONAFIDE. NONETHELESS, IT WILL GAIN AN AUDIENCE IN
BURUNDI AND PERHAPS ELSEWHERE AMONG THE UNEDUCATED AND
THOSE WHO HEAR OF IT SECOND-HAND.
3. INFORMAL EMBASSY TRANSLATION OF LETTER FOLLOWS.

BEGIN TEXT.
MISTER PRESIDENT:
WE ARE SORRY TO INFORM YOU THAT YOUR PENITENTIARY IN
BUTARE IS A WELL-KNOWN CENTER IN THE TRAFFIC OF ILLEGAL
DRUGS PRODUCED IN YOUR COUNTRY, RWANDA.
THE DIRECTOR OF THIS ESTABLISHMENT, MR. KAJANGO, IS A
VERY ACTIVE LINK IN THE INTERNATIONAL DRUG NETWORK AT
THIS CENTER. HE ENJOYS GREAT CREDIBILITY AMONG HIS
FRENCH DRUG-TRAFFICING FRIENDS BECAUSE OF THE FACT THAT
HE CLAIMS THAT HE MAINTAINS CLOSE CONTACTS WITH YOU AND
THAT HE HAS CLOSE AND INTIMATE RELATIONS WITH ONE OF
YOUR SISTERS-IN-LAW, WHO IS ALWAYS SEEKING ADDITIONAL
(INCOME), AND THAT THIS SISTER-IN-LAW IS IN FACT YOUR
FAVORITE. ALL THESE AFFIRMATIONS OF MR. KAJANGO HAVE
GIVEN THE IDEA TO HIS FRIENDS, AS THEY HAVE REVEALED TO
US DURING INTERROGATIONS, THAT YOU ARE A SECRET
CORRESPONDENT OF THIS NETWORK.
