ON JANUARY 23 AT ABOUT 4:00 P.M., MUJAWAMARIYA WAS STOPPED AT AN ILLEGAL ROAD BLOCK IN THE GITEGA SECTION OF KIGALI. THE BARRICADE WAS MANNED BY MEMBERS OF THE INTERAHAMWE, THE MILITIA OF THE MRND POLITICAL PARTY. MEMBERS OF INTERAHAMWE THREATENED TO KILL HER; ONE WAVED IN HER FACE A LARGE KNIFE WITH BLOOD ON IT. FORTUNATELY, MME. MUJAWAMARIYA MANAGED TO FRIGHTEN THE CROWD BY TELLING THEM
