**SUBJECT:** Appointment Request: President Juvenal Habyarimana of Rwanda

**REQUEST:** Office call by President Habyarimana on Friday, October 8. The Government of Rwanda requested this meeting.

**PURPOSE:**

- The Rwandan President wishes to thank the United States for its assistance in the peace process and to seek support for implementation of the peace accords signed on August 4.
- Your meeting would underscore the Administration's commitment to support peaceful conflict resolution throughout Africa and elsewhere.

**OTHER APPOINTMENTS SOUGHT:**

The Government of Rwanda has requested a meeting at the White House at the highest available level. (In a separate memorandum, we have proposed a meeting with the Vice President.)

**BACKGROUND:**

The Government of Rwanda and the Rwandan Patriotic Front signed a peace accord on August 4, ending three years of war. The United States played a major role in the peace talks in Arusha, Tanzania, and President Habyarimana is now traveling to countries that assisted in the peace process to express his thanks.
