1. [REDACTED] DEPARTMENT IS SENDING ROBERT HOUDEK, AMBASSADOR
DESIGNATE TO ERITREA AND FORMER DEPUTY ASSISTANT SECRETARY
FOR AFRICAN AFFAIRS, TO HEAD THE U.S. DELEGATION TO THE
SIGNING OF THE RWANDAN PEACE ACCORDS ON AUGUST 4 IN
ARUSHA. ROBERT FLATEN, AMBASSADOR TO RWANDA, WILL BE THE

SECOND MEMBER OF THE DELEGATION.

2. MR. HOUDEK WILL DEPART WASHINGTON ON AUGUST 1 AT 1735 VIA UA FLIGHT 950 TO BRUSSELS, ARRIVING AT 0710 ON AUGUST 2. HE DEPARTS BRUSSELS AT 1020 VIA SABENA FLIGHT 565, AND ARRIVES IN NAIROBI AT 2145 ON AUGUST 2. HE WILL STAY OVERNIGHT IN NAIROBI AND DEPART FOR ARUSHA BY LAND ON AUGUST 3. ALTHOUGH HIS RETURN HAS ALSO BEEN TICKETED, HIS ACTUAL RETURN QERARY WILL DEPEND ON THE SCHEDULE IN ARUSHA.

3. FOR KIGALI: PLEASE COORDINATE AMBASSADOR FLATEN'S TRAVEL PLANS WITH NAIROBI SO THAT MESSRS. HOUDEK AND FLATEN CAN, IF AT ALL POSSIBLE, MEET UP IN NAIROBI AND TRAVEL TO ARUSHA TOGETHER.

3. FOR NAIROBI: PER REF (C), PLEASE MEET AND ASSIST MR. HOUDEK. WE UNDERSTAND THAT RESERVATIONS WILL BE MADE FOR HIM TO OVERNIGHT AT THE NAIROBI HILTON ON AUGUST 2. WORKING WITH KIGALI, PLEASE ARRANGE NECESSARY TRANSPORT FOR MESSRS HOUDEK AND FLATEN FROM NAIROBI TO

ARUSHA VIA CAR OR BUS, AS APPROPRIATE, ON AUGUST 3.

4. FOR DAR ES SALAAM: PER REF (B), WE UNDERSTAND THAT YOU ARE MAKING APPROPRIATE HOTEL ARRANGEMENTS FOR MESSRS. HOUDEK AND FLATEN IN ARUSHA. PLEASE INFORM NAIROBI OF RESULTS SO THAT THE INFORMATION CAN BE PASSED TO MR. HOUDEK.

5. FOR PARIS: MR HOUDEK WILL BE STOPPING IN PARIS ON HIS RETURN TRIP TO DISCUSS RWANDA AND LIBERIA, AND POSSIBLY OTHER ISSUES, WITH THE GOF. SEPTTEL INSTRUCTIONS WILL FOLLOW.
