2. SUMMARY. THE PARTIES IN ARUSHA ARE STILL DEADLOCKED ON THE ISSUE OF WHETHER TO INCLUDE THE CDR IN THE TRANSITIONAL CABINET. NO AGREEMENT HAS BEEN SIGNED.

SUMMARY.

3. THE ISSUE OF THE CDR PARTICIPATION IN THE CABINET REMAINS THE STUMBLING BLOCK; THE RPF IS ADAMANT IN ITS REFUSAL TO INCLUDE THE CDR. THE GOVERNMENT, HOWEVER, IS STATING THAT NO AGREEMENT CAN WORK IF SIGNIFICANT FORCES ARE EXCLUDED FROM PARTICIPATION.

4. THE RPF HAS KINTED PRIVATELY THAT THEY WOULD BE WILLING TO ACCEPT CDR PARTICIPATION IN THE TRANSITIONAL ASSEMBLY, PROVIDED THE CDR AGREED TO ABIDE BY THE CONDITIONS LAID DOWN FOR POLITICAL PARTICIPATION BY THE BISHOPS, I.E., FORSWEARING
